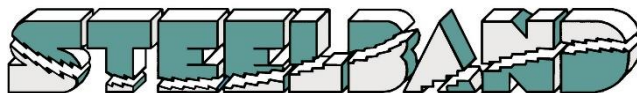

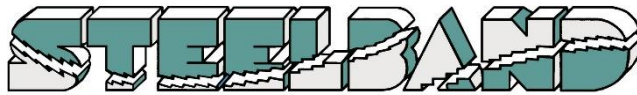

International policies and terms

INTRODUCTION: For all the products depicted and described in our catalogues and in our pricelists any variation can be changed without notice and obligation of communication. The images included in our catalogues or in our price lists or on our website are indicative only.

ORDERS: All orders received, whether direct or indirect, shall have our approval and can not be revoked in the event of our acceptance. Orders are dispatched within the limits of availability under the terms of the agreed date of delivery which are in any case not binding. We reserve the right, unless otherwise provided, to communicate any changes to delivery delay and process orders with partial dispatches. We can not accept any cancellation of order for special products or items not in our price list in force, even if the delivery was delayed.

DELIVERY TERM: Ex Works Monza. Freight charges: none if transport is made by customer, to be added on invoice if done with our forwarder.

PRICES: Prices are ex Works (our standard packing included), and not binding but indicative as they have sudden changes due to increases in raw material. Unless written different, will be valid only those in effect at the time of shipment. All prices are VAT excluded. The rules shown on the orders of the customer different from our general conditions of sale, prices, discounts and other records shown are not valid.

PAYMENTS: Payments may only be made as stated on our invoice. Shall not be rounded with arbitrary deductions and shall respect the amount indicated in our invoices. Delay in payments due to any reason, are subject to bank interest under the terms of the law about the default interest for late payments and other expenses incurred as a result of outstanding or protect our credit. In addition, in the event of suspension of payments by the customer, for any reason, we have the right to cancel the fulfillment of supply commitments still existed. Any disputes about the quality of the goods, delivery or otherwise, shall not constitute a valid element to disrupt or delay the payment terms in accordance with the deadline stated on the invoice. All materials supplied remain our property until fully paid.

SHIPPING: The goods should travel at the sole risk of the customer, even if shipped prepaid or via carrier selected by us. In no event we shall not accept claims for non-delivery by the carrier, for lack of material or for any other reason, such as loss, theft etc., which must be addressed exclusively to the carrier on which it falls all responsibilities. The receiver of the goods it's required to verify the material at arrival, indicating any reservations for shortages, damages or other differences on the receipt document of forwarder. Our responsibility ceases upon collection of the goods by the carrier or consignee.

RETURNS: we must first authorize any return before dispatching it. Should be made only DDP Monza and accompanied by a shipping document indicating the number of our delivery note and the invoice with which the supply was made and the relevant technical details of the alleged problem. The material authorized to be returned must be packed in original packaging and of course be in good condition. Will not be taken into account returned goods when return date is dated later than six months from date of our invoice.

COMPLAINTS: All complaints concerning product defects must be reported in writing immediately and in any case no later than eight days from receipt of the goods by holding the goods available for our verification. After this time we do not accept complaints and the invoice shall be considered accepted. Shortages, damages, etc. during transport must be reported exclusively incurred on receipt of the goods to the carrier on which it falls all responsibilities. Our responsibility ceases upon collection of the goods by the carrier.

JURISDICTION: For any dispute, the only jurisdiction is the court of Monza, Italy.

NOTES: Minimum order is € 150.00 per order. In the case of lower orders we charge € 10 for administrative expenses. The minimum package for the blades with width up to 13 mm is 10 pieces each. We do not make weld service for carbon blades up to 13 mm included. We could make weld for big orders with not standard delivery time.
